### **Agreement**

The sponsoring organization agrees upon signing this agreement:

- Sponsor agrees to indemnify and hold harmless Grand Island Area Clean Community System, their directors and employees from all liability, judgment, costs, expenses, and claims growing out of damages, or alleged damages of any nature whatsoever to any person, property, or third party arising out of the performance or non-performance of said work.
- No vehicles, equipment, or materials are to be parked or stored within 30 feet from the edge of the pavement, except during times of litter pickup when a vehicle may be allowed to be parked on the shoulder.
- Right-of-way markers and land monuments shall not be removed, altered, or damaged.
- This permit shall be subject to any laws now in effect, or any laws which may be hereafter enacted, and all applicable rules and regulations of local, state, and federal agencies.
- The sponsor shall carry on the work as required and authorized by this agreement with serious regard to the safety of the traveling public, adjacent property owners, and volunteers or employees of the sponsors. Traffic protection signs will be loaned to the sponsor for use in traffic control and returned to Grand Island Area Clean Community System at 3661 N Sky Park Rd 2B when litter removal is completed.
- The sponsor acknowledges that all individuals involved in this project are initiators and volunteers directed by the sponsor and that the sponsor accepts full responsibility for any injuries or damages sustained by or caused by such individuals. The sponsor acknowledges that they or their volunteers are in no way considered to be employees of Grand Island Area Clean Community System.

In consideration of the above, the sponsor, Grand Island Area Clean Community System agrees to the following terms and conditions of this agreement.

## Additional Sponsor Responsibilities

- To completely review the Litter Safety Guidelines provided by Clean Community System and make sure all participants are aware of guidelines.
- To perform the work specified in a satisfactory, safe, and professional manner.
- To provide adult supervision at the work site when volunteers or employees are 15 years of age or younger.
- To obtain required supplies and materials as may be needed from Grand Island Area Clean Community System during regular business hours.
- Trash bags will be placed at a predetermined location – to be picked up by the City Street Division or other entity.
- All unused materials and supplies furnished by Grand Island Area Clean Community System shall be returned to them.

## Grand Island Area Clean Community System Responsibilities

- Provide reflective safety vests, trash bags, gloves, pinchers and Litter Pick-up warning signs.
- Provide sponsoring organization with funding as determined by the Nebraska Department of Environmental Quality Cleanup Grant after the litter pick-up has been completed and the sponsor has filled out the appropriate completion form.

## Nebraska Department of Environmental Cleanup Grant Stipulations

- Litter as defined by the Nebraska Department of Environmental Quality:
  - All waste materials susceptible to being dropped, deposited, discarded or otherwise disposed of by any person upon any property in the State, but not including wastes of primary processes of farming or manufacturing. Waste materials as used in this section shall mean any material appearing in a place or in context not associated with that materials function of origin. (Title 133, Chapter 1.013)
- Grant money has been awarded on \$50/mile or \$50/5.0 acre basis (\$10 per acre)
